# **FOREWORD**

This report reflects the continuation of our efforts to execute INQAAHE's strategic plan and the need to move to a sustainable structure for the organization – which is, in itself, an organizational change initiative that is as disruptive as it is promising. Yet, the four pillars of our strategic plan (Sustainability, Quality Culture, Research/Think Tank, and Relevance), and our mission of service to our global quality assurance community, provide a productive framework for the achievements featured in this report.

As is the case with many of you, the global pandemic had a very real impact on our work, requiring yet again a move to a virtual conference and challenges for the GGP reviews. Like many of you, and in collaboration with many of you, it was a barrier that could be overcome with innovation and resilience. Indeed, the many stories of adaptation and new innovations in the work processes of our agencies were featured in many presentations at the

INQAAHE Conference in Glasgow and numerous other convenings in which INQAAHE board and members participated over the year. These are the success stories to be celebrated.

On the topic of celebrations, the Network celebrated a major milestone in its history. INQAAHE's 30<sup>th</sup> anniversary was observed throughout the year in a number of ways. From monthly messages, to quarterly events with international experts, to the publication of a book on the history of INQAAHE, we recognized this milestone. These acknowledgements culminated with the official opening ceremony of the INQAAHE permanent secretariat in Barcelona and an inperson member convening with workshops and meetings.

Our efforts to ensure continuity of leadership for INQAAHE, and the need to create staggered board terms, somewhat ironically meant that the Network welcomed six newly elected board directors and four co-opted directors, all of whom started their first terms this year. We also saw the President's gavel passed from INQAAHE's 7<sup>th</sup> President, Susanna Karakhanyan, who served six years as the INQAAHE President. INQAAHE will greatly benefit from her expertise and insights for the next three years as she serves as the Immediate Past President on the board of directors. I am pleased to note that the incoming board has brought renewed energy, insights and

expertise to INQAAHE governance. With the Executive Committee elected in October during the first board meetings in Barcelona, we are poised for success.

In this year of change and reflection, we also recognized our responsibility to address global trends and to promote the relevance, trust and recognition of the outcomes of higher education. The INQAAHE Board embarked on a process to redesign its Guidelines of Good Practice (GGPs) to better address the ever-diversifying provisions in higher learning. These international hallmarks are applicable to all agencies, including and beyond INQHAAHE members, and provide a modularized approach to the international recognition of quality assurance providers with increasingly diversified practices.

As always, our focus is on the membership, capacity building, and supporting the relevance and professionalization of quality assurance through the INQAAHE Funding Scheme, events and presentations, trainings, and quality review and enhancement activities. - Encourage and assist in continuous improvement amongst member agencies, including professional development and capacity building for the benefit of higher education (HE) institutions, their students and their societies.

- Quality culture: Providing a robust platform for exchange and collaboration

# PART I: INQAAHE PERFORMANCE IN LINE WITH ITS STRATEGIES 2017-2022

# INQAAHE's XXX Anniversary Celebration - Three decades of diffusing quality culture globally

2021 launched with a year-long celebration of the iconic global enhancement platform - the International Network of Quality Assurance Agencies in Higher Education. The INQAAHE and the international QA community celebrated thirty years of contribution to global tertiary education quality assurance, thirty years of spreading quality culture, thirty years of bridging the rich diversity of systems worldwide, thirty years of pioneering and outstanding achievements that pave solutions for current and future success stories of tertiary education systems worldwide.

To celebrate the event as the organization merits, a working group under the lead of INQAAHE President – Susanna Karakhanyan and active engagement of Martí Casadesús Fa, Erika Soboleva and Beatriz Calzada was established. The working group designed a series of memorable events and activities to celebrate the 30 years of outstanding achievements. Some of the highlights were as follows:

- Quarterly events with lead international experts exploring QA and its impact worldwide. In tribute to the invaluable contributions of its leaders throughout the three decades, special sessions were organized with participation of all the past and current Presidents, Board Members, and other key contributors to the quality cause.
- INQAAHE: the History of the First Quality Assurance Network in Tertiary Education was published with the joint efforts of the Presidents and Secretaries of INQAAHE. The publication presents the history of INQAAHE's foundation and evolution while also highlighting the benefits, values and key achievements for which the organization merits acknowledgement. The vision behind the publication was to set a robust platform for future successes by inspiring the new, innovative and passionate leaders through conveying the vision, ambitions, commitment and the passion of the past and current leaders.
- Official opening ceremony of the INQAAHE permanent secretariat in Barcelona. In October 2021, after a long disruption caused by COVID 19, the QA community convened in a hybrid mode (face-to-face & online) to celebrate the 30th anniversary of the organization at the launch of its permanent Secretariat in Barcelona. For the first time in its history, after a floating Secretariat model, INQAAHE endeavors to permanently establish its Secretariat as a firm step towards sustainability of the organization. Approximately 40 participants joined the meeting face-to face and 60 joined the event online.

The celebrations demonstrated the key role and importance of the organization in the wider higher education community and set the path for the next 3 decades of success.

# Operations: statutory and organizational changes

# INQAAHE Legal Incorporation in Spain and Establishment of its International Headquarters in Barcelona

Throughout 2021, the INQAAHE Board, under the lead of the President and support from the Secretariat, engaged in legal incorporation and establishment of the INQAAHE International Headquarters in Barcelona (Spain). In early May, the General Assembly approved the changes made to the Constitution, which now contemplates the transition to a permanent Secretariat, firms the position of Chief Executive Officer, and ensures alignment with New Zealand and Spanish regulation. The international headquarter are based in one of the most central and thriving neighborhoods of Barcelona at the following address: Enric Granados, 33, 08007 Barcelona.

In October, an international delegation status was granted to INQAAHE by the Spanish authorities enabling the organization to operate with an independent secretariat. This allows INQAAHE to legally operate in the country, hire its own staff, implement the proposed organizational structure, and work towards full establishment, among other activities. This legal status of the INQAAHE Secretariat is a major achievement as the Network embarks on implementation of the necessary structural changes to ensure sustainability and long term and fruitful contribution to the HE community.

# Governance of INQAAHE

# **General Assembly Meetings**

In 2021 two General Assembly Meetings (GAM) were held:

• GAM 1, April 27: The first GAM concentrated on the annual reporting (annual achievements, activities and financial statements for 2020) and making decisions on the matters that were crucial for the organizational health and sustainability (upcoming elections and legal incorporation). For sustainability purposes, changes to the Constitution were introduced to firm transition to a Permanent Secretariat, redefinition of the position of Chief Executive Officer and legal requirements necessary to meet the New Zealand

(where the Network is currently established) and Spanish regulation (where the Permanent Secretariat will be based). The President, the Secretary and the Treasurer reported on the annual achievements after which an online voting took place. By early May, the General Assembly approved the INQAAHE Annual Report 2020 (including the Financial Statements for 2020), budgets for 2021 and 2022, revised Constitution, and minutes of the General Assembly meetings held in 2020.

- GAM 2, October 9: The second GAM of 2021 was held in a hybrid mode in Barcelona, during the celebratory event of the INQAAHE 30<sup>th</sup> anniversary and official launch of the INQAAHE International Headquarters. The event constituted a first attempt to initiate in person meeting of the INQAAHE members amid the pandemic. During the meeting, the following key achievements were acknowledged:
  - o The Organizational Structure in its new legal form as an independent secretariat, including the functions of each of the units and delegation of authority, were presented as a proposal.
  - o The newly elected Board members were inducted into the INQAAHE context and culture.
  - o The incoming 8<sup>th</sup> President, Vice-President and Treasurer were elected by the Board and Board's recommendation for the President was formulated for approval by the GA.
  - o A methodology of revision of the INQAAHE GGPs and transformation into INQAAHE's International Standards and Guidelines of Quality Assurance in Higher Education were introduced.
  - o Bids of two QA bodies to host the INQAAHE Conference 2023 were presented for GA voting.

Following the GAM, online voting for the President's candidacy approval and Conference 2023 hosting was launched. As a result of the online voting, Deb Adair was approved as the 8<sup>th</sup> President of INQAAHE. As for the Conference 2023 hosting, IQAA, a Kazakh QA agency, was approved to host the INQAAHE Conference in 2023 in Nursultan, Kazakhstan.

# Board, Committee and Work Group meetings

In 2021 INQAAHE held 10 Board Meetings. The INQAAHE Committees and Working Groups held ongoing meetings while managing and coordinating diverse activities and projects.

On February 9, Vice President Angela Yung-Chi Hou stepped down from her position at the Board to dedicate full-time to academia. During the first Board meeting in 2021, Dr Naji AlMahdi was appointed Vice President for the remaining term of the Vice-President.

The INQAAHE Board, in line with the provisions in the Constitution regarding the staggered approach to the Board formation, announced its 2021 round of Board member elections on July 9<sup>th</sup>. From July 12<sup>th</sup> to August 25<sup>th</sup>, nominations from around the globe were submitted and formed a strong pool of candidates for election. The candidate pool of 16 nominees was broadly

representative of membership types, gender and geography - in line with the INQAAHE key principles.

From September 1st to September 15th, 2021, the General Assembly was invited to elect, through an online voting system, up to 7 candidates to fill the vacant Board positions with terms starting in October 2021. The election was closed on September 15th with 49% participation rate. While the candidate pool had a good balance in terms of gender representation and covered all the regions of INQAAHE - Africa, Arab States, Asia-Pacific, Eastern Europe, Latin America and Caribbean, North America and Western Europe, the election results were skewed towards females and Europe, North America and the Caribbean. To balance Board representation in terms of geographical coverage and gender representation, INQAAHE Board co-opted four Board director positions as per its Constitution, from Africa, Arab States, Asia-Pacific, and Latin America. Based on the newly formed Board, Presidential election was held and Deb Adair was elected President univocally for 2021 (October) - 2024 term. The results of the Board election were approved by the General Assembly by 100% of the participating voters on 18th of October. Susanna Karakhanyan officially passed the gavel of Presidency to Deb Adair, thus becoming an ex-officio on the Board, as Immediate Past President. Deb Adair's inaugural address and Susanna Karakhanyan's farewell address are both available on the INQAAHE website. During the Board meeting in October, Chan Basaruddin was elected Vice-President and Anna Prades Treasurer for the 2021 October - 2024 term.

# **INQAAHE** Branding

To celebrate the evolution of INQAAHE throughout the last 30 years, INQAAHE's image as a global enhancement platform was re-branded as part of the ongoing efforts to sharpen alignment with its mission and highlight the strategies of INQAAHE to enhance relevance in QA. The re-branding focused on the feel and look of the brand and entailed the following key changes:

- Logo: the core elements of the logo were retained the globe and the links among diverse regions to demonstrate the INQAAHE's continued commitment to its initial purpose of enhancement and bridging diversity of cultures. Thus, the simplicity and elegance of the new logo crystalizes the acronym "INQAAHE".
- Colors: the colors were changed into navy blue, purple and silver. Each of the three colors symbolizes a significant element of the organization's mission: blue for education, purple for quality and silver for the dynamic future guided by high tech revolution.
- Fonts: the official font adopted is Aleo.

The Committee on Communication and Outreach updated the *Guidelines on the INQAAHE Branding* and Logo Usage for wide application by the organization and relevant entities.

# Diversification of Funding: revenue and allocations

With the move to a new operating model for the Secretariat, to enhance sustainability of the organization and be able to give back more to our members, INQAAHE has been exploring

opportunities for the diversification of revenue channels. The following have been identified as the potential opportunities:


- Consultancy: In 2020, INQAAHE bid for funding under the auspices of the UNESCO Bangkok office. The project also entailed co-funding by INQAAHE to support the QA system enhancement in Kyrgyz Republic.
- Bespoke trainings for capacity building of EQA and IQA: In 2021, INQAAHE has received requests from its members to deliver trainings catered to the needs of a specific system. A special procedure for such requests is required to ensure a transparent approach to managing such requests.
- Recognition of external quality assurance bodies: With the revision of the GGPs, INQAAHE envisions a revised approach to external evaluation of quality assurance bodies expanding the scope beyond its members and serving all types of QA providers. For this purpose, *the International Standards and Guidelines* are in the process of development to be launched in 2022 and are designed to embrace the diversity of QA providers, instill trust and increase the relevance of QA.

In December 2021, a working group was formed to further explore funding diversification and seek the most optimal avenues for execution of the new revenue streams.

# Membership

INQAAHE is a worldwide association of more than 350 organizations active in the theory and practice of quality assurance in higher education. Four categories of membership exist (Graphic 1):

- GGP ALIGNED MEMBERS are organizations responsible for assuring the quality of postsecondary provisions – institutions and programs, such as accreditation, audit or other bodies responsible for the external evaluation of institutions and/or programs, which have successfully undergone the INQAAHE GGP Alignment procedure and whose alignment is current.
- **FULL MEMBERS** are organizations responsible for assuring the quality of post-secondary provisions institutions and programs, such as accreditation, audit or other bodies responsible for the external evaluation of institutions and/or programs.
- ASSOCIATE MEMBERS are tertiary education institutions or organizations with a major interest in evaluation, accreditation and quality assurance in higher education, but without the responsibility for assuring the quality of institutions or education programs.
- AFFILIATE MEMBERS are individuals with a major interest in evaluation, accreditation and quality assurance in higher education and a proven track record of involvement in tertiary education quality assurance.

# Visibility and Impact

To enhance the visibility of INQAAHE, a series of initiatives were undertaken:

- INQAAHE continued to contribute to the quality assurance events organized by its members. Due to the COVID restrictions those contributions were done in an online mode. Some of the highlights are as follows:
  - o The United Kingdom: QAA UK event on Transnational Provisions in Middle East
  - o **Kazakhstan:** V Central Asian International Forum an online event organized on 1-2 October under the theme *Higher Education Quality Assurance: Global Trends and Regional Aspects* dedicated to the 10<sup>th</sup> anniversary of IAAR.
  - o **Kyrgyzstan:** under the auspices of UNESCO and upon the request of the Kyrgyz Ministry of Education, a national consultation on the revised approaches to QA was conducted. A number of meetings with the Ministry were conducted and a detailed Road Map for enhancement was produced.
  - Lithuania: SKVC Conference entitled Development of external quality assurance: lessons learned and insights for the future, delivered online on December 14. Dr. Susanna Karakhanyan contributed to the event by presenting the global trends in external quality assurance of higher education: disruptions, diversification and differentiation. The full session was broadcasted on <a href="SKVC's Facebook page">SKVC's Facebook page</a> and is available there.

- o **Colombia**: Conference on Learning Outcomes organized by the Ministry of Education. INQAAHE's contribution was on theme Learning Outcomes Assessment: Relevance & Quality in Higher Education.
- o Mexico: Accreditation & Quality Assurance during Pandemic and Post-pandemic
- o **Lebanon:** Best Practices in EQA a round table discussion organized by UNESCO Middle East and Ministry of Education of Lebanon.
- o **Kingdom of Saudi Arabia:** consultation on the revised approach to QA practices by NCAAA.
- o **Pakistan:** Best Practices in External Reviews for Indus University. Online workshop organized by Indus University (Pakistan) on December 2, with the contribution of Dr. Fabrizio Trifiro and Dr. Anna Prades. The recording of the session is available on Indus University YouTube channel.
- A comprehensive Communications and Outreach Strategy was created. In 2021, INQAAHE
  developed and launched a new communication and outreach strategy to improve the
  efficiency and effectiveness of member and media communications. Within the new
  framework, initiatives have been identified to enhance the visibility and impact of
  INQAAHE while better meeting member needs.
- INQAAHE supported UNESCO in their identification of experts for each of the 10 WHEC 2022 themes, based on which they came up with a group of Technical Experts to conduct a study on each of the 10 themes and provide recommendations for policymakers and HEIs.

# **QUALITY CULTURE**

To provide a robust platform for experience exchange and collaboration between the regions worldwide by bridging global quality assurance providers.

To support INQAAHE members in terms of their contributions to national governments in their pursuit of the United Nations' Sustainable Development Goal (UNSDG) #4 on Education Quality.

# INQAAHE Enhancement Platform

Throughout 2021 a number of projects were implemented to provide members with opportunities for professional development and quality enhancement. The highlights include the INQAAHE annual events, webinars and workshops.

# Events, workshops, and webinars

- The DNA of QA: the 10 Es and Beyond: the first event to celebrate the 30<sup>th</sup> anniversary of the Network featuring all Presidents of INQAAHE. Past and present Presidents discussed the DNA of QA with its building blocks evolving around Emergence, Economics, Evaluation, Enhancement, Excellence, Effectiveness, Engagement, Essence, Efficiency, Exceptional and beyond, and respectively addressed the whole journey the global QA has been through, its disruptions, solutions and prospects. The recording of the session is available on INQAAHE's YouTube channel.
- INQAAHE Conference 2021 hosted by QAA, UK: Due to the on-going international travel restrictions, the uncertainty around the safety of large face-to-face gatherings and INQAAHE's ambition to reach out to as many of its members as possible through this event, INQAAHE Conference 2021 was offered fully online supported by QAA, UK and its headquarters in Scotland. INQAAHE's 16<sup>th</sup> Biennial Conference was organized around the theme of *Re-Imagining of Higher Education Quality in an Age of Uncertainty* and was held over the period of 1 10 June to better accommodate multiple time zones.
  - o The Pre-Conference featured four workshops from 1 to 4 June which covered the following topics:
    - INQAAHE's Guidelines of Good Practice (GGP);
    - Professional development of agency staff;
    - Measurement of learning outcome achievement (CLA+);

- QA of Micro-credentials.
- o The main Conference was organized into sub-themes which explored the following major trends through four keynote speeches, paper and poster presentations and breakout sessions:
  - Digital disruption for HE brings disruption for quality assurance;
  - New quality agendas for external and internal quality assurance;
  - Quality assurance supporting changing learner journeys;
  - Maintaining trust in the face of uncertainty.

Overall, there was significant engagement from workshop participants, ranging from 47-63 attendees per workshop, and the Conference was attended by 181 attendees from the INQAAHE 7 regions globally.

- **INQAAHE 30th anniversary celebration:** on 7-8<sup>th</sup> of October INQAAHE organized an extraordinary event to celebrate the 30<sup>th</sup> anniversary. The event was held in Barcelona, in a hybrid mode and hosted 51 participants from 7 regions of INQAAHE and 28 countries. The event was proudly hosted by AQU Catalunya and the University of Barcelona and provided a forum for discussion of global issues regarding internal and external quality assurance and a regional networks meeting focused on the SDGs.
- Planning for INQAAHE Biennial Forum 2022: throughout 2021, INQAAHE Board's Forum 2022 Committee along with the FIMPES Local Organizing Committee worked on the organization of the 2022 Forum in Mexico City. The main theme of the Forum is Sustainable Quality Assurance: Optimizing Synergies between Artificial and Human Intelligence. The Forum will be held in Mexico City, Mexico, from June 6 until June 9, 2022. In preparation for the Forum, in July a call for proposals to facilitate sessions was distributed and proposals were welcomed until October 15, 2021. Sub-themes and pre-forum workshops were development and speakers invited.
- Selection of host for **INQAAHE Biennial Conference 2023**: In November 2020 a bid to host INQAAHE Conference 2023 was announced with geographical preferences highlighted as in Central, East and Southeast Asia; South America and the Caribbean; North America and Francophone Africa. During the General Assembly Meeting of 2021 in October, the INQAAHE members voted for Conference 2023 to take place in Nur-Sultan (Kazakhstan), hosted by the Independent Agency for Quality Assurance in Education (IQAA). INQAAHE Board formed a Conference Organization Committee to launch the preparations with the host.
- Bid for **INQAAHE Biennial Forum 2024:** In November 2021, the bid to host the biennial Forum 2024 was launched. Considering the venues for the INQAAHE annual events for the last ten years, preferences for hosting the INQAAHE Forum 2024 are given to the following regions: East and Southeast Asia; South America and the Caribbean; North America; and Francophone Africa.

# Support to the INQAAHE Members

To promote professionalization of quality assurance, INQAAHE undertakes activities to encourage innovative solutions to quality assurance challenges and supports research in QA. In line with its inclusiveness principle, INQAAHE also allocates funding scholarships for Low Income Countries (LIC) and Least Developed Countries (LDC) to allow the latter to actively access the benefits the Network offers. The INQAAHE Funding Scheme (IFS) envisions provision of small grants to INQAAHE members on a competitive basis to promote implementation of innovation and enhancement projects of quality assurance systems worldwide. In 2021, the INQAAHE Funding Scheme was announced under the following two windows with total allocation of USD \$30,000¹. (Window 1, intended for Board's initiatives was not initiated in 2021).

### Window 2:

o **Capacity building:** Projects under Window 2 are aimed at the development and enhancement of quality assurance systems worldwide. These can include, but are not limited to, trainings, workshops, consultations, revision of the QA frameworks among other key issues. It also includes promotion of internships between different QA institutions, scholarships for the INQAAHE Quality Assurance Program (QAP), and funding for attending INQAAHE annual event.

In 2021 the following capacity building projects were funded and launched:

# INQAAHE's Support to Enhance Quality Systems

In 2020, under the auspices of UNESCO, INQAAHE launched an enhancement project in Kyrgyz Republic. The project, Strengthening Quality Assurance Systems for Higher Education in Kyrgyzstan: Baseline analysis and national consultations, was commissioned by UNESCO at the request of the Ministry of Education and Science (MoES) of Kyrgyzstan. The project aimed to review the current state of affairs of quality assurance at higher education level in terms of internal and external quality assurance and to offer potential solutions for improvement and enhancement.

The review team was led by the International Network of Quality Assurance Agencies in Higher Education (INQAAHE) with technical support from UNESCO's Asia-Pacific Regional Bureau for Education in Bangkok, Thailand. The INQAAHE team was represented by Dr. Susanna Karakhanyan (INQAAHE President), Dr. Martí Casadesús Fa (Director of AQU Catalunya and INQAAHE Secretary), Dr. Stephen Jackson (EU expert on Quality Assurance, UK), Dr. Erika Soboleva (CEO of AKKORK and INQAAHE Board Director) and Beatriz Calzada (INQAAHE Secretariat). The UNESCO Asia-Pacific Regional Bureau was represented by Dr. Libing Wang, Dr. Wesley Teter and Ms. Aisulu Sulaimanova, UNESCO Almaty Cluster Office for Kazakhstan, Kyrgyzstan, Tajikistan and Uzbekistan.

Together with MoES, UNESCO planned and successfully completed three joint actions by July 2021:

- 1. An independent assessment of quality assurance standards and relevant international guidelines in Kyrgyzstan;
- 2. A national consultation on quality assurance systems for higher education;
- 3. Provision of actionable recommendations on implementing quality standards to promote international alignment of quality assurance agencies in Kyrgyzstan.

The project culminated in the development of a detailed road map for Kyrgyz Republic to revise and enhance its quality assurance system in line with its strategic priorities.

# Online Access to the Journal Quality in Higher Education

INQAAHE partners with Taylor & Francis to provide its members with access to the lead journal in higher education quality assurance – *Quality in Higher Education*. INQAAHE members received hard copies of the <u>Journal Quality in Higher Education</u> three times per year for more than 10 years. Starting in 2021, INQAAHE negotiated <u>online access</u> to the journal for its members. The members need a Taylor & Francis Online account to access the journal.

# Contribution to the Body of Knowledge

Contribution to the body of knowledge takes places in a variety of formats:

- INQAAHE Board-initiated research: In 2021, within the frames of re-imagining the INQAAHE GGPs, the INQAAHE Board reflected on the outcomes of INQAAHE's Global Study on Trends in Higher Education Quality Assurance to motivate and energize an initiative to review, update and enhance the Guidelines of Good Practice (GGP). In this context, the Board engaged in a number of regional focus groups aimed at capturing different views on how INQAAHE can contribute to enhance relevance and trust in quality assurance.
- INQAAHE member initiated research encouraged and funded by INQAAHE. In 2021, with INQAAHE's support of the following research projects were launched.
  - o Ensuring Quality Assurance and Accreditation of Distant Education in Kyrgyzstan (EQADEK). A Capacity Building project submitted by the Kyrgyz Agency for Quality Assurance in the field of Education "EdNet" under the frame of INQAAHE Funding Scheme 2020-2021. The main objectives of the project are to improve internal documents on accreditation of non-adapted to distant learning SP of universities due to the pandemic, and train agency experts in terms of their preparation for accreditation using technologies of remote access and online conferences without visiting a university.
  - Transition to Digital Era of Accreditation: Scope and Challenges for Emerging Quality Assurance Agencies. A Research and Innovation project submitted by the University Grants Commission (UGC) of Nepal, under the frame of INQAAHE Funding Scheme 2020-2021. The specific objectives of the study are to explore and compare the impacts

of COVID-19 to the QAA Agencies of technologically developed and developing countries; map the innovative ways initiated by the QAA agencies to assess accreditation in the short-term and long-term; and analyse the cases of specific countries in relation to success and failure when responding to the COVID-19 crisis.

In 2021, the following capacity building and research and innovation projects were granted funds to launch in 2022:

- o Proof-of-concept system based on AI to support decision making on accreditation processes, submitted by the Consejo Nacional de Acreditación (Colombia). The major goal of this capacity building project is to create and validate a proof-of-concept system that will provide the council members of the Colombian Accreditation Council with objective quantitative data that could be used during the process of deciding on the accreditation process.
- o Assessing Institutional Readiness to Implement Quality Assurance Activities: A Case Study of Tertiary Level Colleges in Bangladesh, submitted by Dr. Rozilini M. Fernandez-Chung (Malaysia). The general objective of this research and innovation project is to study institutional readiness and capacity of colleges affiliated with the National University of Bangladesh to implement quality assurance activities.
- o Metrics-driven quality assurance: an overview of international approaches, challenges and opportunities, submitted by Ecctis/UK ENIC (United Kingdom). Through the gathering of the information and intelligence this research will allow, authors aim to better inform the strategic decisions of different national quality assurance bodies and the development of national quality assurance systems, as well as informing the work of INQAAHE to enable the Network to better meet the changing needs of the international quality assurance community.

# • RELEVANCE

To advocate and promote the concept of quality assurance as the driving force for continuous improvement and enhanced relevance of HE.

INQAAHE supports a number of initiatives to promote quality assurance bodies in their efforts to serve the needs set out by national governments and HE systems and to enhance the relevance of QA provision. INQAAHE has developed and applies Guidelines of Good Practice (GGP) to review the alignment of External Quality Assurance Bodies (EQABs) for increased professionalization and relevance of quality assurance provision globally. Looking forward, INQAAHE promotes relevance by emphasizing the links between the labor market and HE provisions, recognizing QA developments, identifying gaps and solutions, and exploring new modes for QA to ensure relevance within an evolving context.

# Guidelines of Good Practice: Manifestation of quality

The professional practices that INQAAHE believes should be embedded in all quality agencies are set out in its *Guidelines of Good Practice in Quality Assurance* 2016 (commonly referred to as GGP). The purpose of the GGP is to promote good practice for internal and/or external quality assurance. The GGP include six sections:

- Section I: The structure of the External Quality Assurance Agency (EQAA)
- Section II: Accountability of the EQAA
- Section III: The EQAA's framework for the external review of quality in higher education institutions
- Section IV: The EQAA and its relationship to the public
- Section V: Decision making
- Section VI: The QA of cross border higher education

2021 witnessed an increased interest in INQAAHE's recognition of External Quality Assurance Bodies (EQABs) against the Guidelines of Good Practice (GGPs). In total, in 2021, 12 applications for GGP were processed, 4 were completed, 2 are in the process and the rest launched/planned to be launched in 2022.

# Quality Hallmarks: An Evolution

First established in 2003, the GGPs have served the mission of promoting and enhancing the QA culture globally. As the QA systems matured and with the education paradigm changing and diversifying, the need to revise the GGPs became obvious. The urgency for this was also widely supported in the INQAAHE Global Study published in 2020. In response to the global trends related to promotion of relevance, trust and recognition of HE outcomes, the INQAAHE Board decided to redesign its Guidelines of Good Practice (GGPs) to address the gaps and the ever-diversifying provisions in higher learning. Thus, a working group was established to further enhance the GGPs by transforming the latter into the International Standards and Guidelines for Quality Assurance in Higher Education (ISGs). The Board's decision to engage in the GGP revision was reaffirmed during Board meeting in December 2021 by the new Board.

The intent of the revisions are to refine the set of guidelines applicable to all EQABs and to also address the diversity across EQABs by developing additional, specialized standards (e.g. for quality assurance of cross-border education) that can be applied depending on the remit of the agency. In addition to this modularized approach, a protocol that recognizes the maturity level of providers will also be developed. The evolution of the INQAAHE Quality Hallmarks will allow them to be applied to all QA providers, including but beyond INQAAHE members, and necessitate an independent decision-making body – outside of the INQAAHE board. Successful EQABs could be awarded a credential and be listed on the INQAAHE register.

The methodology that supports this work includes a literature review and document analysis, followed by a set of global focus group meetings (see table 1). In total, 7 focus groups with 90 participants were held. The Focus Groups covered 47 (24%) of countries and 58 (~17%) of QA bodies globally, out of which 84% were INQAAHE members and the rest outside the membership. The contributions of the focus groups will inform the development work conducted by QA experts with specific expertise – both from the INQAAHE Board and the broader QA community. This work will culminate in a wide stakeholder consultation process that will yield the initial set International Standards and Guidelines for Quality Assurance.

# Marjorie Peace Lenn Center

The Marjorie Peace Lenn Center serves as INQAAHE's center for learning and research. Starting March 2020, the Center partnered with the company MaxKnowledge, to provide training curriculum for quality assurance professionals and university staff in a self-paced, on-line learning format. This platform offers training courses for QA professionals in an on-line learning format, among other resources. The curriculum is available to INQAAHE members, for free or a small fee, depending on the course at inqaahelearn.org.

In 2021 the scope of the MPL Centre activities were re-evaluated. As one of the new initiatives, the MPL will host a webinar series "INQAAHE Talks", designed to provide international perspectives on regional issues, and broader discussions on global issues. The Committee is also engaged in supporting members with targeted -training and capacity building activities.

# **NOTES TO THE FINANCIAL STATEMENTS**

### RESULT - NET LOSS/SURPLUS FOR REPORTING PERIOD

The result for the year 2021 amounts to **6,062.42 USD** positive, which represents a considerable decline from the previous year. This decrease is due to a slight decrease in revenues (of 9%) and an increase in expenditures (33%). The increase in expenditures is mainly due to the regularisation of accounts receivable (bad debt account, included in Other expenses), to professional fees related to the Kyrgyzstan project (which were covered by the corresponding Grant received between 2020 and 2021) and the celebration of the 30<sup>th</sup> INQAAHE anniversary in Barcelona.

# **EQUITY**

The period ends with a positive result, and an equity of 688,103.67 USD.

### **BANK ACCOUNTS**

INQAAHE is in a good financial situation. The Network's bank accounts have continued to increase over the last year.

As a reminder, INQAAHE operates in USD and the Secretariat currently manages two different bank accounts, both established in Spain: one of them in US dollars (the main one) and another one in Euros (secondary).

### **ACCOUNT RECEIVABLES**

Receivables amounted to 99,264.57 USD, a 27% less than in 2020. As a reminder, in 2020, INQAAHE, given the economic difficulties derived from the global pandemic, the effort of collecting outstanding invoiced relaxed considerably and members who were in arrears for more than two years (as stated in our <u>Financial Policy</u>) did not have their memberships discontinued. In 2021, 35 members were deemed uncollectable and were written off from INQAAHE's membership.

Because these members were in arrears for more than two years, this has made the Bad Debts account to increase considerably compared to 2020 (168%).

### **FIXED ASSETS AND DEPRECIATION**

A new computer hardware equipment was purchased at the end of 2019 for 1,103.34 USD.

The depreciation of fixed assets is calculated using the straight-line method over their estimated useful lives of the assets concerned, based on the actual decline in value caused by wear and tear, being the period of time four years after the assets are brought into operation. The amount allocated for depreciation was registered on December 31, 2021. Depreciation for this computer was calculated as follows:

Active value: 1,103.34 USD

Provision years: 4 (275.84 USD/year)

Provision 2019: 2 months (invoice date October 25, 2019) = 45.97 USD

Provision 2020: 275.84 USD Provision 2021: 275.84 USD

Accumulated depreciation = 45.97 + 275.84 + 275.84 = 597.64 USD

The INQAAHE website, purchased for 19,614 USD, was operative on November 18, 2016. 2019 was the last year the website accumulated depreciation. During that year, 30 hours of website developments should have been added to the value of the website and depreciated accordingly. Since this was not done then, it was corrected in 2020 and calculations have continued in 2021 accordingly The overall amount of the website depreciation adds up to 20,829 USD this year.

# **LIABILITIES**

In terms of liabilities (24,757 USD), most of them (16,500) are related to INQAAHE Funding Scheme grants (Capacity Building and Research and Innovation) provisioned for the following year. At the end of 2021 INQAAHE had 8,257 USD in Accounts Payable.

# **TOTAL REVENUE**

INQAAHE incomes are currently classified into six categories: membership fees (annual and review fees), GGP Alignment (review and recognition procedures), grants and consultations (external projects), INQAAHE events (including training courses and webinars as well as the annual forum or conference), sponsorships (of INQAAHE events and the quarterly newsletter) and other (mainly related to international bank transfers).

The total 2021 income, 350,461 USD, diminished by 9% compared to 2020 (383,721 USD). This decrease is mainly explained by a slight reduction (6%) in membership fees, which are the main revenue source of the Network, and the fewer number of GGP Alignment procedures carried out in 2021 if compared with the previous year.

# **MEMBERSHIP FEES**

Our annual membership fees have not changed since 2012. Here is a detail of the fees depending on the type of the country of the member:

Regular 2021 Membership fee = 690.65 USD

LDC/LIC countries (as per <u>The World Bank</u> and <u>UN</u>) 2021 Membership fee = 345.33 USD

Review fees = 100 USD

The reported total membership fees of 251,958 USD include annual membership fees (along with fees from LDC/LIC countries) for the reporting year, as well as review fees (charged to applicants for INQAAHE membership).

Taking a conservative approach, it was estimated that 25% of all pending membership fees would not be successfully collected during 2022 (33.088 USD).

# **CONTRIBUTIONS FROM EVENTS**

Revenue from INQAAHE Conference 2021 registration fees, hosted by the Quality Assurance Agency (QQA) and delivered online, amounted to 13,659.96 USD. The expenses of the face-to-face celebratory event for INQAAHE's 30<sup>th</sup> anniversary in Barcelona amounted to 14,800 USD.

### **GGP ALIGNMENTS**

Income collected from GGP alignments in 2021 (38,250 USD) originated from four different agencies seeking alignment (through the review pathway).

# **TOTAL EXPENDITURES**

2021's general expenditures (344,345 USD) are higher than 2020's (258,778 USD), which were exceptionally low. The categories of expenses with the highest increased are Other expenses, which includes Bad debts, Event related expenditures and expenditures related to Grants and Consultations (these include consultancy fees from experts and professionals involved in INQAAHE projects).

### **FUNDING SCHEME GRANTS**

A total of 14,654 USD was expensed during 2021. This amount corresponds to part of a Capacity Building grant and one Research and Innovation grants, and one grant to Quality Assurance Programme.

### FEE TO SECRETARIAT AND SECRETARIAT TRAVEL EXPENSES

The annual fee INQAAHE pays to AQU Catalunya to host the Network' Secretariat, 62,000 USD, was settled in three bank transfers, one ordered in January 2021, a second one in June 2021 and a third one in October 2021.

### FINANCIAL STATEMENTS

This account also includes any travel expense applicable to Secretariat staff, but no expenses were incurred in 2021.

#### **JOURNAL**

The cost for the Journal varies from year to year, depending on the number of INQAAHE members and the exact currency exchange between GBP and USD (invoices are always issued in British Pounds). Taylor & Francis, the publishing company in charge of distribution, issued an invoice for their 2021 of 8.172 USD.

### **WEBSITE HOSTING AND DEVELOPMENTS**

All developments related to the new INQAAHE website are being registered in the fixed assets category of the Statement of Financial Position. Expenses in 2021 for this concept amounted to 191 USD, similar than in 2020 or 2019, and it exclusively refers to hosting as no new developments were done.

### **EXPENSES FOR BOARD MEMBERS**

The expense executed in 2021 consist of the compensation of eight Board Directors for the event celebrated in Barcelona in October. As per INQAAHE's <u>Financial Policy</u>, when an INQAAHE Board Member attends, in its entirety, the meetings of the INQAAHE Board of Directors held before and after INQAAHE events (i.e., biannual conferences or fora), the Members' agencies are provided with 1,000 USD to be used toward partial reimbursement of travel-related costs to attend the meeting. In addition, each Board Member in attendance will receive a 500 USD personal honorarium.

#### **BANK CHARGES**

Banking expenses executed in 2021 were 5,496 USD versus 6,081 USD executed in 2020. These costs include wire transfers and POS fees, mainly. They vary depending on the amount paid and/or received and the conditions of every bank that operates with INQAAHE's.

### LOSS/GAIN ON FOREIGN EXCHANGE

The loss on foreign exchange in 2021 was 1,054 USD versus last year's 1,998 USD gain.

We have applied the gain/loss at the currency exchange of 31/12/2021 USD/EUR to the following EUR accounts: balance at bank account and other registered monetary accounts registered in EUR. The transactions (incomes and expenses) executed in EUR are always recognised in the functional currency (USD) by applying the currency exchange rate published in BOE, the Spanish Official Bulletin (http://boe.es/).
